Welcome to LuxLinX. These Terms & Conditions ("Terms") govern your access to and use of the LuxLinX mobile application and website (together, the "Service"), operated by LuxLinX ("LuxLinX," "we," "us"). By creating an account, downloading the app, or using the Service, you agree to these Terms.

1. Eligibility

You must be at least 18 years old to use LuxLinX. Certain experiences — including nightlife venues and bottle service — may require you to be 21 or older. You are responsible for meeting the age and entry requirements of any venue or provider.

2. The Service

LuxLinX is a discovery and planning platform. We help members find experiences — nightlife, dining, yachts, rides, jets, and similar — and organize plans with other members. **LuxLinX does not own, operate, or provide the experiences listed on the Service.** Venues, charters, and other providers are independent businesses responsible for their own services, pricing, and policies.

3. Plans & Cost Splitting

The Service allows members to host or join plans and view estimated per-person costs. Cost figures shown in the app are **estimates provided by hosts or members** and are not quotes or guarantees. Any payments, reservations, or agreements are made between members and/or providers directly. Hosts are responsible for the accuracy of their plans and for honoring commitments made to guests.

4. Member Conduct

You agree to use the Service respectfully and lawfully. You will not misrepresent yourself, harass other members, post unlawful or offensive content, or use the Service for any fraudulent or illegal purpose. We may remove content or suspend accounts that violate these Terms.

5. Safety & Assumption of Risk

Meeting other members and attending experiences involves inherent risk. Use good judgment when joining plans or meeting people through the Service. To the fullest extent permitted by law, you assume all risks arising from your participation in any experience arranged through the Service.

6. Intellectual Property
